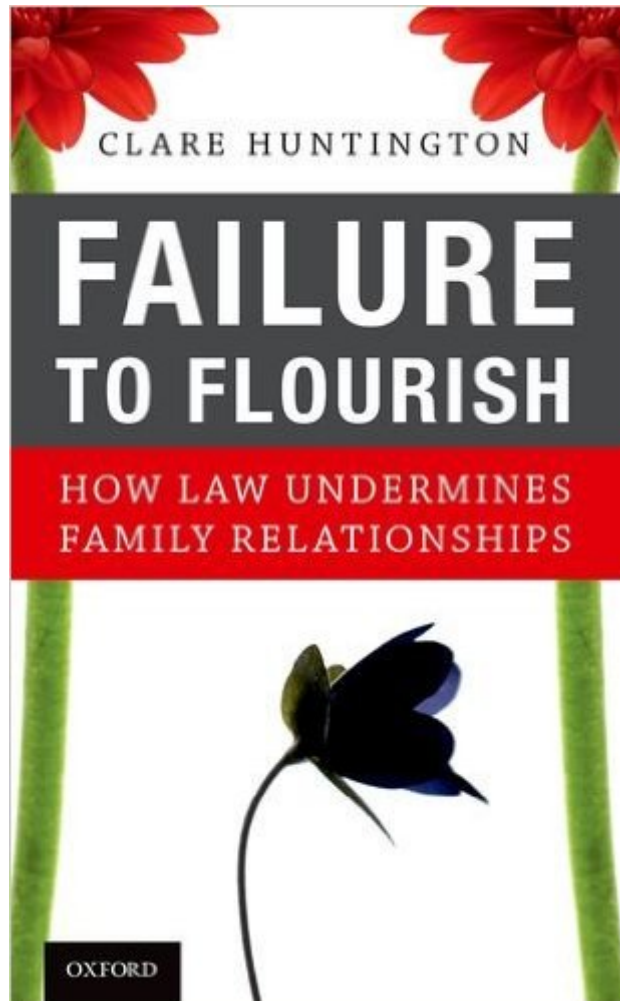

Exploring the connection between families and inequality, *Failure to Flourish: How Law Undermines Family Relationships* argues that the legal regulation of families stands fundamentally at odds with the needs of families. Incorporating the latest insights of positive psychology and social science research, the book sets forth a new, more emotionally intelligent vision for a legal system that not only resolves conflict but actively encourages the healthy relationships that are at the core of a stable society.
